#### **D.A.N. "Flying after Diving" Recommendations Acknowledgment Waiver**

Revised Flying after Diving Guidelines for Recreational Diving - May 2002

The following guidelines are the consensus of attendees at the 2002 Flying after Diving Workshop. They apply to air dives followed by flights at cabin altitudes of 2,000 to 8,000 feet (610 to 2,438 meters) for divers who do not have symptoms of decompression sickness (DCS). The recommended preflight surface intervals do not guarantee avoidance of DCS. Longer surface intervals will reduce DCS risk further.

- *For a single no-decompression dive, a minimum preflight surface interval of 12 hours is suggested.*
- *For multiple dives per day or multiple days of diving, a minimum preflight surface interval of 18 hours is suggested.*
- *For dives requiring decompression stops, there is little evidence on which to base a recommendation and a preflight surface interval substantially longer than 18 hours appears prudent*

#### **General Release Assumption of Risk, Waiver of Liability and Indemnity Agreement**

Applicant understands that acceptance on this dive trip is predicated on Applicants assurance that Applicant is physically fit to engage in ocean SCUBA diving and that Applicant has had sufficient training to engage in ocean SCUBA diving. Applicant full understands the SCUBA diving is a hazardous and dangerous sport and Applicant voluntarily assumes all risk of loss, damage, injury or death, which may be sustained by Applicant while engaged in a *Tierra Mar Travel / El Mar Diving Center* diving program.

Applicant and Applicants personal representatives, heirs, executors, administrators, successors, assigns and next of kin, hereby releases, waives and discharges *Tierra Mar Travel / El Mar Diving Center* and its officers, directors, agents, employees, instructors and dive masters for all liability to Applicant. Applicant hereby indemnifies and holds harmless *Tierra Mar Travel / El Mar Diving Center* diving program.

It is understood that *Tierra Mar Travel / El Mar Diving Center* is independent of and has no business association, as partner, joint venture, owner or otherwise, with any resort, hotel, carrier, boat operator, dive operator, or other person or firm furnishing any services.

It is extremely understood and agreed that *Tierra Mar Travel / El Mar Diving Center* assumes no responsibility or liability for availability, service, transportation, safety, quality or condition for the acts (negligent or otherwise) of any employee or agent of such establishment, firm or entity. It is also understood and agreed that *Tierra Mar Travel / El Mar Diving Center* does not, by any acceptance of this Applicant, assume any responsibilities for liability for the safety of any participating individual, particularly while such individual is engaged in underwater activities, whether alone or in a group, under the supervision of the tour escort, or otherwise.

It is further understood that remoteness of the area, local customs and prevailing weather may cause substitution of facilities and/or equipment, minor inconvenience or modification to the diving portion of the program itinerary and *Tierra Mar Travel / El Mar Diving Center* reserves the right to modify and/or cancel diving arrangements due to unfavorable weather conditions or otherwise.

This application form signed by Applicant and by the parent or guardian of any minor applicant is in all respects subject to the terms and conditions above, which have been read and unconditionally agreed to. Applicant declares that Applicant has read and understands the content here of and voluntarily sign this **General Release Assumption of Risk, Waiver of Liability and Indemnity Agreement and D.A.N.
